FEES:

- > A non-refundable Booking Fee of \$500+GST NZD is due at the signing of this contract. This will confirm a place for the above mare in this stallion's book. This fee is deductible from the Service Fee of \$2000+GST NZD.
- > The balance of the Service Fee (\$1500+GST NZD) is payable before the first shipment of semen is sent.
- > There is no Collection Fee for the first shipment of semen. Each subsequent shipment will be liable for a \$250+GST NZD Collection Fee (this covers semen collection, preparation, packaging etc).
- > Transport Fees will be invoiced to the Mare Owner for each shipment of semen.

SEMEN RESERVATIONS:

- > Payment of the Service Fee confirms your mare's reservation to be bred to **EURO SPORT KALASKA** in the breeding season extending from 1st September 2023 until 1st April 2024. Collections past this time by arrangement with Euro Sport Horses only.
- > Please contact for semen requirements as early as possible. Delays in communication can make timely semen deliveries difficult.

CONDITIONS OF RETURN SERVICE & LIVE FOAL GUARANTEE:

- > 1. If your Mare fails to get in foal, another mare may be nominated with permission from Euro Sport Horses. A vet notification of the mare being empty will be required first.
- > 2. If your Mare fails to get in foal she will be accepted for the 2024/25 season.
- > 3. If your Mare produces a live foal that is unable to stand or suckle and it subsequently dies within 48 hours, your Mare is eligible for a return service. A veterinary certificate must be provided to Euro Sport

Horses within 10 days of the foal's death. This certificate must also state that the mare was properly cared for during gestation and was professionally supervised at foaling. Failure to provide the certificate within the given period will make the return of service null and void.

- > 4. If the mare dies you can substitute for another mare.
- > 5. If the stallion dies you may choose another of Euro Sport Horses stallions to complete the service.
- > 6. Services are interchangeable between all stallions with permission from Euro Sport Horses.
- > 7. All rights of return to **EURO SPORT KALASKA** do not include collection and transport fees.
- > 8. All mares must be foaled under professional supervision and with an on call vet available for live foal guarantee (LFG) to be valid.

WARRANTY:

Euro Sport Horses will not be liable for lost, damaged or delayed semen due to circumstances beyond their control.

ISSUE OF BREEDING CERTIFICATE:

One Breeding Certificate will be issued for this contract. This will pertain to the Mare described in the contract. This will be provided once the Mare is tested 42 days in foal and all outstanding invoices have been paid by the Mare Owner.
